1. REGISTRATION

- a. A deposit of 35% of the total cost + **plus \$500 damage deposit.**
- b. **Final balance** is due eight weeks prior to start date.
- c. You agree that you are not aware of any physical or other reasons which would restrict you from participating in all or any part of the semester.
- d. You agree that Yamnuska Mountain Adventures will begin committing resources and other expenses to prepare for your participation in the Summer Mountain Semester (SMS).
- e. Yamnuska may contact you in the future via email or post for feedback or marketing purposes (you can unsubscribe).

2. CONDITIONS OF REGISTRATION

- a. **Waiver:** Participation is conditional upon signing the Yamnuska Mountain Adventures waiver of Risk and Liability. The Waivers will be completed on the first day of the MSS.
- b. **Medical:** The medical form is for your benefit and is a way of advising us of past medical history. By registering for the SMS, you agree that you are able to complete three months of demanding physical activities in what can be a harsh environment. Based on your Doctor's recommendation, we reserve the right to exclude you from certain segments of the SMS. Normal cancellation policies apply. If you have doubts regarding your physical or other capabilities, you should receive your Doctor's clearance PRIOR to registering for the SMS. The Medical Form does not relieve you from the booking and cancellation policies. We recognize injuries and life events after your registration may change your availability to participate fully or partially on the SMS so we strongly recommend you purchase medical and trip cancellation insurance. If you do not have a current provider we can recommend one.
- c. **Refunds & Cancellations:** Many of the SMS expenses are incurred and committed by Yamnuska Mountain Adventures while preparing for students to attend the semester. Our cancellation policies reflect the fact that we cannot recover most costs after late cancellations. We accept your booking in good faith and begin committing resources to make the SMS a high quality educational experience for you. This is a significant investment for both Yamnuska Mountain Adventures and the student and in order for us to fulfill our obligations to you, we need to commit/incur resources and expenses on your behalf.

3. **CANCELLATION:** If cancelling call Yamnuska Mountain Adventures immediately, which must be followed by notice in writing. The following cancellation terms apply:

IF AN APPLICANT CANCELS:

1. Up to 57 days before the program start
2. Between 56 days and 42 days before the program start
3. Cancellation less than 42 days before the program start and during the program

YAMNUSKA WILL RETAIN:

\$100.00 (plus tax) administration fee and less a 4% service fee
60% of the program cost
Entire amount paid

- a. **DAMAGE DEPOSIT:** A damage deposit of \$500.00 is required from each participant prior to course start. This deposit is to defray the cost of repairing or replacing any gear damaged or lost through student misuse or inattention. If abnormal damage or loss does not occur the deposit will be refunded at the end of the course.
- b. If tuition is not paid in full on dates due, Yamnuska Mountain Adventures may regard this as cancellation on your part.
- c. Yamnuska Mountain Adventures reserves the right to cancel courses and refund fees without penalty to Yamnuska Mountain Adventures.
- d. Yamnuska Mountain Adventures reserves the right to refuse admission to or expel anyone who is a danger to the environment, her/himself, or others, for gross misconduct, or who, in the opinion of the company or its agents, would be unable for any reason to satisfactorily complete the course requirements.
- e. No refunds will be given to anyone expelled from the semester for gross or persistent misconduct, illegal drug use, illegal behavior, deliberate and/or maliciously dangerous behavior.
